Report of the Committee on Non-Governmental Organizations on its 2011 regular session

(New York, 31 January-9 February and 3 March 2011)

Summary

At its 2011 regular session, held from 31 January to 9 February and on 3 March 2011, the Committee on Non-Governmental Organizations had before it 352 applications for consultative status, including applications deferred from its 1999 through 2010 sessions. Of the non-governmental organizations those applications, the Committee recommended 112 for consultative status, took note of 1 non-governmental organization that had withdrawn its application, closed consideration without prejudice of 23 applications and deferred 216 for further consideration at its resumed session in May 2011. The Committee also had before it 10 new requests for reclassification of consultative status; it recommended granting 5 of those requests. It also considered one deferred request for reclassification and recommended the reclassification. The Committee considered seven requests for change of name of which it took note of six and deferred its consideration of one of the requests to the next session. In addition, it had before it 231 quadrennial reports, of which it took note of 212. Pending the receipt of responses to questions posed, the Committee deferred its consideration of 16 quadrennial reports deferred from previous sessions and 3 from the present session. Of the 27 non-governmental organizations that attended the session, the Committee heard 13 representatives of those organizations.

The present report contains two draft decisions on matters calling for action by the Economic and Social Council.

By draft decision I, the Council would:

- (a) Grant consultative status to one hundred twelve non-governmental organizations;
- (b) Reclassify the consultative status of six non-governmental organizations;
- (c) Note the withdrawal of the application of one non-governmental organization;
- (d) Note the change of name of six non-governmental organizations;
- (e) Take note of the two hundred twelve quadrennial reports of non-governmental organizations;
- (f) Close without prejudice consideration of the request for consultative status made by twenty-three non-governmental organizations after the organizations had failed to respond to queries over the course of two consecutive sessions.

By draft decision II, the Council would take note of the present report.

Report of the Committee on Non-Governmental Organizations on its 2011 regular session

1. The Economic and Social Council takes note of the report of the Committee on Non-Governmental Organizations on its 2011 regular session.

II. Applications for consultative status and requests for reclassification, change of name and withdrawal of application received from non-governmental organizations

2. International Lesbian and Gay Association

7. At its 10th meeting, on 4 February, the Committee considered the application of the non-governmental organization International Lesbian and Gay Association.

8. The representative of Belgium, supported by the representative of the United States of America, called on the Committee to take a decision during the session on the application of the International Lesbian and Gay Association. He emphasized that members of the Committee had had ample time to consider the responses of the organization to the questions posed to it, since it had first applied over 10 years before. The representative of the Sudan stated that the Committee was still waiting for the non-governmental organization to submit a response to the questionnaire provided by the Committee. The representative of Morocco enquired of the Secretariat, on procedural grounds, whether voting on an application was possible while there were still outstanding issues regarding an organization.

9. The representative of Belgium stated that, while remaining fully respectful of the different positions taken by Committee members, he was nevertheless requesting a vote on the application without further delay. The representatives of Belgium and the United States of America stated that they believed the non-governmental organization had responded adequately to all issues covered in the questionnaire and that the posing of further questions was being used not to gain more information but to delay the decision-making process. Additionally, the representative of the United States of America affirmed that advocating for lesbian, gay, bisexual and transgender rights should not be used by the Committee as a disqualifying factor when it considered whether to grant consultative status. The representative of the Sudan, reiterating his position that no action should be taken while there were still questions awaiting a satisfactory answer from the organization, called for a no-action motion as regards the proposal of the representative of Belgium.

10. Citing rule 50 of the rules of procedures of the Economic and Social Council, the Secretary of the Committee stated that it was necessary first to vote on the no-action motion. If the motion proposed by the Sudan was carried, the debate on the application of the International Lesbian and Gay Association would be adjourned and the application of the International Lesbian and Gay Association would remain on the list of deferred applications.

11. The representatives of the United States of America and Bulgaria spoke in opposition to the no-action motion, while Senegal spoke in support of the motion.

12. The no-action motion was carried by a roll-call vote of 9 to 7, with 1 abstention and 2 absent. The voting was as follows:

In favour:

Burundi, China, Morocco, Nicaragua, Pakistan, Russian Federation, Senegal, Sudan, Venezuela (Bolivarian Republic of).

Against:

Belgium, Bulgaria, India, Israel, Peru, Turkey, United States of America.

Abstaining:

Kyrgyzstan.

Absent:

Cuba, Mozambique.

13. The representatives of Nicaragua and Venezuela (Bolivarian Republic of) stated that their delegations had voted in favour of the motion on procedural grounds, while the representative of Nicaragua further stated that she was willing to recommend the granting of consultative status to the non-governmental organization.

Applications closed (without prejudice)

14. At its 16th meeting, on 9 February, the Committee decided to close (without prejudice) consideration of the applications of 23 non-governmental organizations that, despite three reminders sent to them over two consecutive sessions, had not responded to the Committee's questions (see chap. I, draft decision I, para. (g)).

Withdrawal of application

15. The Committee took note of the request of one non-governmental organization to have its application withdrawn (see chap. I, draft decision I, para. (c)).

Requests for change of name

16. At its 16th meeting, on 9 February, the Committee considered seven requests by non-governmental organizations for change of name, as contained in document E/C.2/2011/CRP.4, and took note of the requests of six of those organizations (see chap. I, draft decision I, para. (d)).

17. At the same meeting, the Committee deferred, to its resumed session in May 2011, consideration of the request for change of name of the following organization:

Feminist Club (Special 2005) to the *Caucasian Feminist Initiative*

B. New applications for consultative status and new requests for reclassification

18. The Committee considered agenda item 3 (b), New applications for consultative status and new requests for reclassification, as contained in document E/C.2/2011/R.2 and Add.1-16, at its 3rd to 8th and 13th to 16th meetings, from 1 to 3 and on 8 and 9 February.

New applications recommended

19. Of the 171 organizations whose new applications had been received, the Committee recommended that the following 61 should be granted consultative status with the Council (see chap. I, draft decision I, para. (a)):

Requests for reclassification

21. At its 11th meeting, on 7 February, the Committee, having considered requests from 11 organizations for reclassification of consultative status, as contained in documents E/C.2/2011/R.3 and E/C.2/2011/CRP.3, as decided to recommend reclassification of 3 of those organizations from special to general status and 3 from the Roster to special status (see chap. I, draft decision I, para. (b)).

22. The Committee decided to defer consideration of the matter of the reclassification of consultative status of the following five organizations:

23. With respect to the International Union against Cancer, the Committee, having considered the request of the organization for reclassification, which had been deferred from previous sessions, decided to recommend reclassification from the Roster to special consultative status.

III. Quadrennial reports submitted by non-governmental organizations in consultative status with the Council

A. Deferred quadrennial reports submitted by non-governmental organizations in consultative status with the Council

24. At its 11th meeting, on 7 February 2011, the Committee had before it a memorandum by the Secretary-General containing a compilation of 23 quadrennial reports submitted by 19 non-governmental organizations in consultative status with the Council on their activities during the period 1999-2010, whose consideration had been deferred from previous sessions of the Committee (E/C.2/2011/CRP.2). 26. At the 11th meeting, on 7 February, a draft decision for consideration by the Committee was introduced by the representative of the United States of America under agenda item 4 (a), Deferred quadrennial reports submitted by non-governmental organizations in consultative status with the Council, by which note would be taken of the quadrennial report of Amnesty International, consideration of which had been deferred for two years. The representative of Cuba stated that while he did not wish to further defer consideration of the report, he wished first to receive answers to the questions posed. After a discussion among the Committee members, they agreed to adjourn briefly in order to consider the information available on the organization's website concerning the questions posed, which was then distributed. After consideration of the information by its members, the Committee took note of the report by consensus without proceeding to consideration of the tabled draft decision. Subsequently, the representative of Cuba stated that the distribution of the information available on the website of the non-governmental organization should not constitute a precedent in respect of future consideration of quadrennial reports.

B. Review of quadrennial reports submitted by non-governmental organizations in consultative status with the Council

27. The Committee considered item 4 (b) of its agenda, Review of quadrennial reports submitted by non-governmental organizations in consultative status with the Council, at its 11th meeting, on 7 February. It had before it a note by the Secretary-General containing 208 new quadrennial reports (E/C.2/2011/2 and Add.1-16), of which the Committee took note of 205 (see chap. I, draft decision I, para. (e)).

28. The Committee decided to defer consideration of the new quadrennial reports submitted by the following three organizations, pending receipt of their responses to questions posed by the Committee:

Becket Fund for Religious Liberty

International PEN

29. At the 2010 regular session, held from 25 January to 3 February 2010, during consideration of the application for consultative status of the non-governmental organization Plan Sweden, it had been brought to the attention of the Committee that Plan Sweden is a member of the larger umbrella non-governmental organization Plan International, which has enjoyed Roster status since 1981. The Committee consequently decided to request a report from Plan International for consideration at its 2011 regular session with a view to deciding whether to recommend that it be reclassified, as appropriate, in accordance with paragraph 61 (c) of Economic and Social Council resolution 1996/31. At its 11th meeting, on 7 February, the Committee recommended reclassifying Plan International from the Roster to special consultative status (see chap. I, draft decision I, para. (b)).

IV. Strengthening of the Non-Governmental Organizations Branch of the Department of Economic and Social Affairs of the Secretariat; and General voluntary trust fund in support of the United Nations Non-Governmental Organizations Informal Regional Network

30. At its 1st meeting, on 31 January 2011, the Committee considered jointly agenda item 5, Strengthening of the Non-Governmental Organizations Branch of the Department of Economic and Social Affairs of the Secretariat, and agenda item 8, General voluntary trust fund in support of the United Nations Non-Governmental Organizations Informal Regional Network, and heard oral reports made by the Secretariat.

31. Statements were made by the representatives of the Sudan and China, who welcomed the noticeable improvements in the work of the Branch, encouraged continued progress and expressed their support for further strengthening of the Branch.

Other related matters

Recommendations for improving the working methods of the Committee

32. At the 11th meeting, on 7 February 2011, following informal discussions, proposals were considered for improving the working methods of the Committee and expediting the process of reviewing applications. The Committee agreed to utilize the time allocated for dialogue with non-governmental organizations for this purpose only. At its 16th meeting, on 9 February, the Committee agreed to hold an informal intersessional meeting before the start of the resumed session in order to continue its discussion on the matter.

VI. Consideration of special reports and complaints by Member States

33. The Committee had no special reports before it at its 2011 regular session.

VII. Organization of the session

A. Opening and duration of the session

34. The Committee on Non-Governmental Organizations held its 2011 regular session from 31 January to 9 February and on 3 March 2011. The Committee held 17 meetings (1st to 17th).

35. The session was opened by the Vice-Chair of the 2010 sessions of the Committee, Edgard Pérez (Peru), who served as temporary Chair.

36. At the 1st meeting, on 31 January, the Chair of the Committee, Aydan Karamanoğlu (Turkey), made an opening statement. An introductory statement was made by the Director of the Office for Economic and Social Council Support and Coordination of the Department of Economic and Social Affairs of the United Nations Secretariat.

B. Attendance

37. The session was attended by 19 members of the Committee. Observers for other States Members of the United Nations, observers for non-Member States, representatives of organizations of the United Nations system and observers for non-governmental organizations also attended. The list of participants will be made available from <http://www.un.org/ecosoc/ngo>.

38. At its 2011 regular session, the Committee heard 13 representatives of non-governmental organizations, who were given the opportunity to respond to questions raised by the Committee. The additional information provided by the representatives facilitated the debate and the work of the Committee in taking its decisions.

C. Election of officers

39. At its 1st meeting, on 31 January, the Committee elected Aydan Karamanoğlu (Turkey) as Chair and Marghoob Saleem Butt (Pakistan), Mansour Ciss (Senegal), Edgard Pérez (Peru) and Maria Pavlova Tzotzorkova (Bulgaria) as Vice-Chairs.

40. At the 16th meeting, on 9 February, it was decided that the Vice-Chair (Pakistan), would also serve as Rapporteur.

D. Agenda

41. At its 1st meeting, on 31 January, the Committee approved the provisional agenda for its 2011 session as contained in document E/C.2/2011/1. The agenda reads as follows:
